The Florida Department of Transportation (FDOT), District Four, will conduct a Public Information Meeting regarding the Complete Street Project on SR 811/ NE 4th Ave/ Wilton Drive from Sunrise Boulevard (SR 838) to NE 26th Street. PROPOSED IMPROVEMENTS

The purpose of the project is to add buffered bike lanes, through the repurposing of one (1) vehicle traffic lane in each direction from Sunrise Boulevard to NE 26th Street. In addition, the project includes sidewalk improvements and provides landscape opportunity areas from NE 20th Street to NE 9th Avenue. This project also includes upgrading the existing roadway lighting to LED (light-emitting diodes) luminaries.
