US 1 IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT), District Four, will conduct a Construction Open House regarding the improvements on US 1 from Oakland Park Boulevard to Commercial Boulevard in Oakland Park and Fort Lauderdale. This will be conducted as an informal open house beginning at 5 p.m. Representatives will be available to provide pertinent information and answer questions. Construction plans will be available for public viewing.

PROJECT IMPROVEMENTS

- Removing existing asphalt and resurfacing the road from north of Oakland Park Boulevard to south of Commercial Boulevard
- Repairing sidewalks along the roadway, and constructing Americans with Disabilities Act (ADA) compliant curb ramps
- Adding a designated 4-foot bicycle lane on both sides of the roadway
- Upgrading pedestrian signals at NE 33 Court, NE 43 Street, NE 38 Court and Floranada Road

TRAFFIC IMPACT

- Access to properties will be maintained at all times.
- Lane closures will not occur between 7 a.m. and 9 a.m. or between 3 p.m. and 6 p.m.
- Milling and resurfacing operations will take place overnight between 10 p.m. and 7 a.m.
- Concrete construction of curbs, sidewalks and driveways will take place between 9 a.m. and 3 p.m.
