The Florida Department of Transportation (FDOT), District Four, will conduct two Public Information Workshops regarding the improvements along the SR 816/Oakland Park Blvd. corridor. These workshops will have an open house format, with representatives available to answer questions. The same design plans and project information will be available for public viewing at both workshops. Please stop by at a workshop at your convenience.

PROPOSED IMPROVEMENTS

- Construct designated bike lanes or shared lanes (Sharrows) on the following local roadways:

City of Lauderdale	City of Ft. Lauderdale
Inverrary Blvd. W;	Middle River Dr.; Access Road E;
Environ Blvd.;	NE 32nd St.; NW 33rd Ave. S.;
NW 55th Ave	NE 30th Ave.; NE 30th St.;
	Access Road W; N. Atlantic Blvd.

- Modify and relocate drainage structures and regrade swale areas impacted by roadway widening;
- Construct new sidewalks and ADA upgrades;
- Install Transit Signal Priority equipment at intersections to allow transit buses signal timing efficiency. This element is being coordinated with Broward County

- Construction Cost Estimate : **\$3.6 million**

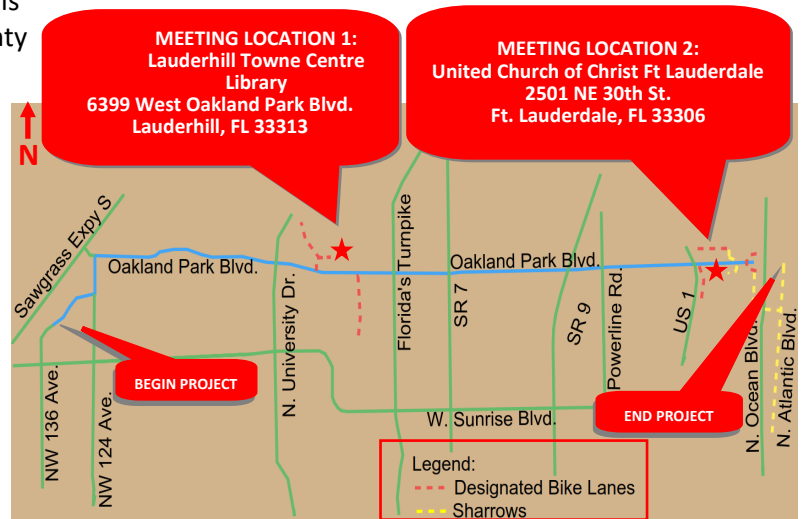
