NW 21ST AVENUE MOBILITY IMPROVEMENT/BRIDGE REPLACEMENT PROJECT

The Florida Department of Transportation (FDOT) District Four, will conduct a second construction open house regarding the bridge replacement and widening on NW 21st Avenue in the Cities of Oakland Park, Fort Lauderdale, and Tamarac. FDOT is conducting this meeting to provide residents an additional opportunity to review project information. The meeting will have an informal open house format beginning at 5:00 p.m. Representatives will be available to provide pertinent information and answer questions. Construction plans will be available for public viewing.

The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. The Broward MPO is a federally-mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward. PROJECT IMPROVEMENTS

- Replacing the existing bridge over the South Florida Water Management District C-13 Canal
- Widening the roadway to accommodate a 5-foot bicycle lane in each direction
- Installation of traffic signal mast arms at NW 39th Street and NW 44th Street
- Installing sidewalks and curb ramps

TRAFFIC IMPACTS

- Access to residences, businesses, and Oakland Park Fire Station 87 will be maintained at all times
- Delays may occur as construction crews work within the project limits
- Traffic will be maintained in each direction during
- Lane closures may occur from 9:30 p.m. to 6:00 a.m.
- NW 44th Street will be closed periodically at NW 21st Avenue during night operations; traffic will be detoured to NW 39th Street


