CORDOVA ROAD FROM SE 17TH STREET/SR A1A TO SE 15TH STREET ROADWAY IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT), District Four, will conduct a Public Hearing regarding the proposed improvements along Cordova Road from SE 17th Street/SR A1A to SE 15th Street. These improvements will be implemented on behalf of the City of Fort Lauderdale and the Broward MPO. The purpose of this Public Hearing is to gather input before any changes to access are finalized. This Public Hearing will be offered in two different formats: virtual and in-person. The in-person Public Hearing session will be in compliance with all current COVID-19 guidelines and social distancing will be followed. Both formats will consist of a formal presentation followed by comment period and open discussion. Staff will be available to answer questions and provide assistance. Comments and questions will be responded to as time permits, in the order received. If your question is not responded to during the event, a response will be provided in writing following the Hearing. Questions and comments may also be submitted prior to the Hearing by e-mailing the Project Manager. Persons wishing to submit written statements, in place of or in addition to oral statements, may do so by sending them to the Project Manager. PROPOSED IMPROVEMENTS

- Lane repurposing including one northbound lane elimination which was evaluated and approved by the City of Fort Lauderdale.
- Mill and resurface to accommodate bike lanes.
- Construct two pedestrian midblock crossings with Rectangular Rapid Flashing Beacons (RRFB).
- Install pedestrian lighting.
- Construct a curbed median to introduce traffic calming and modify access to driveways along Cordova Road to enhance pedestrian safety.
- Intersection improvement at SE 15th Street.

CONSTRUCTION IMPACTS

- All lane closures during non-peak hours will be accompanied with detours for traffic being impacted.
 - Daytime non-peak hours: 9:00 AM to 4:00 PM Monday through Friday.
 - Nighttime non-peak hours: 9:00 PM to 5:30 AM Sunday through Thursday.
- During the complete road closure of northbound Cordova Road, road users will be detoured via SE 10th Avenue.
- All work is to be done in phases to reduce impacts of construction to the community.
- Access to businesses and private properties will be maintained at all times during construction.






EXISTING TYPICAL SECTION NO. 1 (SE 17TH STREET TO SE 16TH STREET) FACING NORTH
